

INSTITUTION OF OCCUPATIONAL SAFETY AND HEALTH (IOSH)

Institution of Occupational Safety and Health (IOSH) is a Chartered body and leading membership organisation for safety and health professionals.

IOSH WORKING SAFELY

IOSH Working Safely course is designed specifically to train employees from a wide range of back- grounds of the basic principles of health and safety in the workplace. The course covers the fundamentals of working safely especially the importance of individual responsibilities when it comes to work- place accidents.

Duration: 1 day

IOSH MANAGING SAFELY

IOSH Managing Safely course is designed for non-health and safety personnel who have to manage risk and resources. It is also suitable for those with responsibility for health & safety. It is designed to provide an overview on health & safety based on risk-based approach to prevent accidents in the workplace.

Duration: 4 days

FIRE

FIRE WATCH

The Fire Watch training course will ensure that all employees are suitably trained in the safe use of Fire extinguishers and their inspection requirements.

FIRE WARDEN

This qualification is aimed at all staff, where a basic understanding of fire safety is required. Learners gaining this qualification will know that fire safety is the responsibility of everyone in the workplace and will recognise their contribution in the prevention of fires and fire spread.

FIRE MARSHAL

This qualification has been developed for anyone involved in the management of fire safety in the workplace. This could include managers, supervisors, team leaders, fire wardens (marshals) and staff working in any area where there is a potential risk of fire.



FIRST AID

EMERGENCY FIRST AID AT WORK

This qualification has been developed for those already working, or preparing to work, in the industry and who have been identified in the company's first aid risk assessment as being required to provide first aid in the workplace.

ADVANCE FIRST AID AT WORK AND THE SAFE USE OF AED

Qualification includes roles and responsibilities of a first aider, assessing incidents, managing causalities as well as knowing how to safely use an AED

BLS AND THE SAFE USE OF AN AED

This qualification is recommended for learners who wish to be able to manage an unresponsive casualty who is breathing normally, and know how to safely use an automated external defibrillator.

PAEDIATRIC FIRST AID

This qualification is recommended for learners already working or preparing to work in the industry and to provide candidates, who are responsible for the welfare of infants and children, with the necessary knowledge, understanding and skills to support first aid and the use of a defibrillator in the workplace.

LIFTING

RIGGING AND SLINGING


To train delegates in the principles that support the correct slinging of different types of loads, in the safety precautions to be taken whilst working with rigging equipment, and in the inspection and use of all associated equipment.

LIFTING SUPERVISOR

This course covers the functions required to be undertaken by a Lifting Supervisor to meet the minimum formal training and assessment standards for the purposes of certification through Workplace Health and Safety.

LIFTING OPERATIONS - APPOINTED PERSON

This course is suitable for supervisors and managers with responsibility for lifting operations. This course will give you an understanding of the appointed person's responsibilities and how to fulfil them.



SCAFFOLDING

SCAFFOLD ERECTION AND DISMANTLING

This course is meant for anyone who is involved in practical Hands-On erection and dismantling of several types of basic frame, tube & coupler, and "system" scaffolds.

SCAFFOLD SUPERVISOR

In accordance with the new standard – all supervisors who erect frame, system or tube and coupler supported scaffolds must be certified. This course covers the safe erecting, use, inspection, modification and dismantling of supported base scaffolds.

SCAFFOLD INSPECTOR

All international standards and QCS regulations require that all scaffolds are inspected by a certified "Inspector". This course covers the complete inspection procedures as per international standards.

SCAFFOLD SAFETY AWARENESS

Awareness course is for anyone who is working on or around scaffold. This course can be conducted for delegates in any level and serves its purpose to educate about scaffold safety.

Course objective is to provide delegates with the knowledge and skills to enable them to erect, alter and dismantle basic scaffolding structures in traditional tube and fitting and common system scaffold types.


ECITB

LEAD AUDITOR COURSES

ISO 9001 : 2015 LEAD AUDITOR

Learn the principles and practices of effective quality management system audits compliant emphasizing your ability to conduct 2nd party assessments of suppliers and sub-contractors.

ISO 14001 : 2015 LEAD AUDITOR

The course is designed to equip the delegates with a basic understanding of the principles of environmental auditing and to furnish them with the knowledge, skills and techniques necessary to participate as a team member for environmental audits.

ISO 45001:2018

This requires organisations to review and continually improve their occupational health and safety performance. Organisations should conduct regular occupational health and safety audits.

ISO 22001:2018

This course provides delegates with the knowledge and skills required to perform first, second and third-party audits of food safety management systems against ISO 22000.

IMS AUDITOR TRAINING

This three-day course provides a detailed understanding of different standards and the knowledge and skills necessary to effectively implement an integrated management

FOOD SAFETY

FOOD SAFETY AWARENESS

This qualification has been principally developed to improve awareness of the importance of food safety in the catering and hospitality sectors and provides food handlers with the knowledge of how they can contribute to food safety.

FOOD SAFETY FOR SUPERVISORS

This qualification has been developed specifically to improve the food safety knowledge of supervisors, team leaders and line managers working in the catering industry. This includes those working in care.

FOOD SAFETY MANAGERS

This qualification has been developed specifically for managers working in a food or drink catering environment, whose job requires them to have some responsibility for food safety (and also possible responsibilities for an operational team)

HACCP TRAINING

This qualification has been developed for caterers and those in roles that involve handling food. Topics covered include the principles of HACCP, food safety management, the implementation of HACCP, hazards and controls, critical control points, critical limits and target levels, monitoring, corrective action and verification.

HACCP FOR SUPERVISORS

This qualification has been developed for those responsible for assisting in the development and maintenance of HACCP systems. It is also suitable for those owning/managing smaller food businesses. Topics covered include HACCP food safety-based management procedures, preliminary processes, the 7 principles of HACCP, legislation, allocating roles and responsibilities, hazards and risks, monitoring proce- dures, corrective actions, documentation and record keeping.

HACCP FOR MANAGERS


